MEMBERSHIP POLICY

- Introduction to Judo Memberships are valid for a participant only in their first year of membership to Judo NS.
- Maximum program length is 15 weeks.
- No grading; white belt only; not eligible to vote at the AGM; cannot participate in competition or similar activities (i.e. organized randori).
- To upgrade to regular membership, full fees are owed.

1.4. School Program

- Official letter from the school where the program is taking place submitted annually to Judo Canada by Judo NS, including a detailed schedule.
- Program must take place during school hours only.
- Program must be conducted under the supervision of school personnel or follow the "Rule of 2".
- Not eligible to vote at the AGM; cannot participate in competition or similar activities (i.e. organized randori).
- Maximum grading to orange belt with registration of promotion to Judo NS.
- To upgrade to regular membership, full fees are owed.

1.5. After-school program

- Official letter from the organization where the program is taking place submitted annually to Judo Canada by Judo NS, including a detailed schedule.
- Program must be under the supervision of an adult staff member or follow the "Rule of 2".
- Not eligible to vote at the AGM; cannot participate in competition or similar activities (i.e. organized randori).
- Maximum grading (all promotions are required to be registered with Judo NS):
 - Primary School No restriction.
 - Secondary School Maximum green belt.
- To upgrade to regular membership, full fees are owed.
